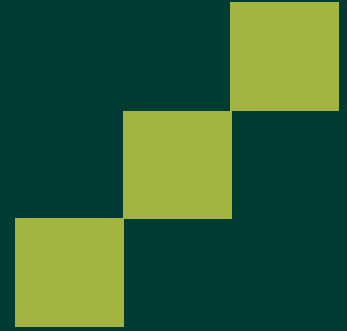

# DEAN'S WELCOME

I am delighted to welcome incoming students to the Law School for 2024. It is always heartening to witness the new generation of persons who will become the legal minds of the future, a sensation that in my case has not abated since starting my career at this Law School over 30 years ago. This year it is my privilege to view this in my capacity as Interim Dean. To this end, I very much look forward to meeting you. And this will be in person, as our lectures and tutorials/workshops are conducted in person (although the former are also recorded). We are proud to continue our tradition of face-to-face interactive teaching and learning activities.

You are entering a Law School with a long and illustrious history - the fourth oldest in Australia - with an equally longstanding strong culture of research coupled with a commitment to excellent teaching. The high level and impact of our research is disproportionate to our size, and means that you will be taught by senior scholars of national and international standing. And this commences from Year 1, where Professor Jan McDonald will be coordinating Foundations of Law, Professor Tim McCormack and Associate Professor Jeff McGee share International Law teaching and Professor Jane Nielsen will be your main instructor in Torts. The small size of classes - in both lecture and tutorial/ workshop format - ensures not just ready access to some of the brightest legal minds in the State, but the opportunity to engage in effective peer-to-peer learning. It also facilitates a closer connection between students, and with this the building of strong relationships over time, during which you will develop an identity as a Law student. After all, you will be pursuing educational and social engagements, in our dedicated Law building, with its own Law Library and other student spaces.

In view of the foregoing, I recommend that, aside from making it a priority to attend your scheduled classes, you devote time to get to know your fellow students, across the span of year cohorts. You will find that our primary Law student body - the Tasmania University Law Society (TULS for short) - is very active across the breadth of Law School life. We as academics are always keen to give TULS a voice from an academic perspective - for instance, one or more TULS representatives attend staff meetings and sit on the Faculty's Learning and Teaching Committee - in order to ensure that we remain responsive to student input and concerns. TULS is a most proactive student body and aims to ensure the best student experience, including from a social perspective. Through the academic year, to this end, many social functions are conducted under its auspices, in which academic staff often participate. I also recommend you get involved with other associations within the Law School, such as COMET, SEALS and the International Justice Initiative.

You will see that the Law School is very much a happening place, and we welcome you to join with us to foster a memorable student (and staff) experience.

# MEET A FACULTY MEMBER

## Dr Yvette Maker



**‘Read as much and as often as you can’**

### **Short summary of career**

I have a background in law and policy and I’m especially interested in the design of human rights-compliant laws, policies and practices in relation to mental health, disability and social services and systems, as well as the role of emerging technology in promoting (or risking) people’s rights. Prior to joining UTAS, I was a researcher at the University of Melbourne’s Centre for AI and Digital Ethics and the Melbourne Social Equity Institute.

I have also worked in the public service (at the Administrative Appeals Tribunal and Australian Competition and Consumer Commission in Perth and Melbourne) and as assistant to then-Vice Chair of the United Nations Committee on the Rights of Persons with Disabilities, Prof Theresia Degener, in Geneva. My most recent books are *Care and Support Rights After Neoliberalism* (CUP 2022) and *The Future of Mental Health, Disability and Criminal Law* (co-edited with Kay Wilson, Piers Gooding and Jamie Walvisch) (Routledge, 2024).

### **What do you do at UTAS?**

I’m a Senior Lecturer in Law and a member of the Faculty Leadership Team. With my teaching hat on, I coordinate LAW108 Legal Reasoning and Technological Change for first years and the elective units LAW231 Disability, Mental Health and the Law and LAW261 Legal Theory.

I also run the UTAS Clinical Legal Education Program (comprising two units: LAW344 Public Interest Law Clinic and LAW345 Legal Professional Experience). In the Clinical Legal Education program, students in the latter stages of their degree can gain practical experience, and contribute to access to justice in the community, by working in our Student Legal Service here on campus and in a semester-long placement with a community legal organisation.

When I’m not teaching, I am researching and writing, or eating pastries, or both.

### **If you had one piece of advice for a new law student, what would it be?**

Read as much and as often as you can! The best way to learn legal writing, legal research, legal referencing and legal reasoning is to see how other people do it and build on their style to develop your own.

# TASMANIAN LEGAL PRACTICE COURSE



## What, Why & When?

Many of you will be thinking about what your next step will be following completion of your law degree. If you intend to practice law, you will need to complete a Practical Legal Training course to be eligible for admission as a legal practitioner.

The Tasmanian Legal Practice Course (also known as the Graduate Diploma of Legal Practice) is the only course of this type offered in Tasmania. It offers unique practical training and provides you with invaluable skills. Each year trainees attend the TLPC for different reasons: some intend to practice law; some are unsure if they want to practice law and find the practical work assists with their decision; some to keep their career options open should they choose to practice law in the future; some to expand their qualifications and opportunities in the job market; and others are keen to gain skills, such as advocacy and letter writing to use in other professional roles.

The TLPC is recognised nationally as providing excellent quality training. It offers a unique practical experience unlike any other practical legal training program and will be different to any other course that you will have studied at university. It is the bridge between the theory of law and the practice of law, providing outstanding support from the legal profession, judiciary, and magistracy for practical skills training.

## Highlights of the TLPC

- a strong advocacy component with trainees appearing in our Courts before Judges and Magistrates on a weekly basis
- a client interviewing program conducted with real clients through the Hobart Community Legal Service
- workshop style teaching with an emphasis on learning through practice
- face-to-face teaching, support and mentoring with minimum online learning
- a social and collegial environment
- Employment opportunities - each year many private employers seeking a graduate legal practitioner or Judge's Associate advertise their positions directly to trainees attending the TLPC.

# MEET A FACULTY MEMBER

# Prof. Jan McDonald



**‘we must do safe, responsible research’ to find out if such technologies can ‘buy us some time’**

#### **Short summary of career**

Jan began tutoring in her final year of university in Brisbane. It was this work that inspired her to pursue a career in academia as she enjoyed the moment when she could see things ‘fall into place’ for her students. While she also has a passion for research, teaching was the thing that led her into academia.

#### **What do you do at UTAS?**

Jan specialises in climate law, especially how the law can help us adapt to the impacts of climate change. For the last eight years, Jan’s research has focussed on the law and policy relating to two controversial types of climate intervention. The first is what she describes as the “Voldemort of climate policy” – technologies to reflect sunlight back into the atmosphere to lower global temperatures. Recognising that the Paris Agreement temperature limits are likely to be exceeded, Jan argues that ‘we must do safe, responsible research’ to find out if such technologies can ‘buy us some time’, while also ensuring that it doesn’t make governments complacent about the urgency of mitigation. The second type of intervention is to draw carbon dioxide from the atmosphere on large scales and permanently store it.

These carbon dioxide removal technologies are already part of the Paris framework, but need to be massively ramped up if we are to achieve temperature limits.

#### **If you had one piece of advice for a new law student, what would it be?**

Jan considers consistency, time-management and prioritisation to be the key to success for new law students. She states that you cannot expect to be a full-time law student on 20 hours of study each week. As soon as students recognise that law takes time and is lots of work, they have to be able to give themselves time to succeed. After all, ‘no law student in history has ever said “there wasn’t much reading.”’

#### **What would your last meal on earth be?**

Thai food, in particular, Kwanjai in Kingston (they have the best tofu). But she’d prefer to go hungry than forego a good cup of tea!

#### **Favourite holiday destination**

Walls of Jerusalem National Park – Jan has done many walks in Tasmania over many years, but Walls of Jerusalem fills her with a unique joy.

#### **How did you spend your summer break?**

Jan wrote a research grant proposal, hung out at the beach, and operated a holiday taxi service for teenage children.
